Biographical/historical note:

Lemuel Sanford (1699-1780), was the progenitor of this particular branch of the family. He and his wife Rebecca Squire, had sons Hezekiah (1731-1798), Lemuel (1740-1803) and Ezekiel (1742-1808). Hezekiah had sons Aaron (1757-1849) who married Lydia Hawley and was a church deacon, Hezekiah (1762-1834), William (1764-1837) and Zalmon (1767-1809). Lemuel had son Lemuel (1769-1831) who married Mary Heron. For more information on the family see Jacobus's <u>History and Genealogy of the Families of Old Fairfield</u> and Samuel Orcutt's <u>History of the Towns of New Milford and Bridgewater</u>.

Scope and content note:

The collection consists primarily of legal documents related to members of the Sanford family of Fairfield, Redding and New Milford. The series are arranged chronologically by the date of birth of the person who created or received the documents.

Series A contains the estate settlement, 1799, and a copy of a slave manumission, 1806, from the estate of Hezekiah Sanford (1731-1798). The papers of Aaron Sanford (1757-1849) are arranged in Series B. They consist of a religious diary, 1818-1842; pulpit notes, n.d.; legal documents, including a bond concerning a slave, 1806, a list of his taxable estate, 1822, and a codicil to his will, 1842; a selection of writings to his son, n.d.; and farm account books, 1785-1827, 1837-1842, which contain diary-type entries and genealogical notations. Lemuel (1769-1831) is represented in Series C by deeds, 1795-1839, a power of attorney document, 1826, and an appointment, 1827.

Series D contains documents related to various family members, including a 1775 promissory note to Lemuel (1740-1803); a deed to Lydia Sanford, wife of William (1764-1837); two letters from Horace N. Sanford of Bridgewater, who is stationed at Fort Hooker in Virginia, to a friend named Lyman, 1863, describing life in an army camp; and an insurance certificate, 1882, issued to Daniel Sanford for his home in Easton.
