#### Biographical/historical note:

Derby Anderson's father, Nils, purchased the Southport Savings Bank building on Main Street in Southport in 1981; Derby is currently (1997) renovating the building and uses it for his law office. While cleaning out the building, he discovered these materials and donated them to the Historical Society.

The Southport Savings Bank was the creation of 52 prominent men in the village of Southport. They obtained a charter from the Connecticut General Assembly and elected officers. The first president was Frederick Marquand; vice presidents were William Wakeman, Edwin Sherwood, and Augustus Jennings; the secretary/treasurer was Francis D. Perry. Elected as trustees were Joseph Alvord, George Bulkley, O. H. Perry, Moses Bulkley, Ebenezer Jesup, Simon Sherwood, William Bulkley, Allen Nichols, Jonathan Godfrey, Samuel A. Nichols, Williams Bibbins, and John Gould.

The bank opened for business on September 25, 1854 in part of the National Bank

building. The trustees authorized construction of a building on Main Street in 1863, and two years later the bank moved into its own quarters. The structure boasted two vaults and an electric burglar alarm. On July 1, 1955, the bank merged with Bridgeport-People's Savings Bank.

The Improvement Association of Fairfield and Vicinity, a membership organization, formed in 1912 for the purposes of eradicating mosquitoes by eliminating breeding grounds and educating the public about the pests. The organization evidently foundered around 1920 and was reorganized in 1922. Charles B. Jennings was the treasurer of the organization as well as Secretary/ Treasurer of the Southport Savings Bank. The Improvement Association worked closely with the Fairfield health department and its head, Dr. Valery Havard.

### Scope and content note:

The collection is arranged in two sub-groups to represent the organizations whose records are included. Sub-group I encompasses the records of the Southport Savings Bank, 1854-1977. Series A consists of legal records, including copies of the Act of Incorporation, 1854, with an 1931 amendment; by-laws and revisions, 1914, 1950, and a record of the vote of the Board, 1911; lists of officers and trustees; minutes of the Executive Board, 1955-1966; and deeds, 1860, 1869.

Depositors' records, 1877-1955, which include descriptions such as "employed at", or "son of," are organized chronologically in Series B. An earlier volume, from 1854-1875, is in Ms B47, Bank Books. Collateral loan records, 1957-1975, are arranged in Series C. Series D consists of a classification of accounts, 1940-1949; statements of condition, 1912, 1945-1954; bills and receipts, 1854-1895, including bills for the telegraph burglar alarm, safes, and other building materials; tax deposits and dividends, 1867-1868; canceled checks, 1865-1879; and blank stationary and forms, n.d. Correspondence, 1854-1966, is arranged chronologically in Series E.

Materials collected and written for the 100th Anniversary celebration of the founding of the bank are arranged in Series F. These include historic and contemporary photographs of the bank, its displays for the celebration, and historic sites and events in Southport; press releases; newspaper clippings; and historical publications, 1954. Series G consists of assorted materials, including HABS drawings of the bank building, 1966; publicity about decorating the Christmas tree outside the bank, 1965-1977; and various printed items.

The records of the Improvement Association of Fairfield and Vicinity, are arranged in Sub-group II. They include a manuscript working copy of the constitution, and correspondence, 1922, concerning the duties of treasurer; the treasurer's account book, 1912-1932; a check book, 1922-1940; labor accounts and an inventory of tools stored in someone's barn, 1917-1924; minutes and treasurer's reports, 1914, 1922; correspondence, primarily concerning the payment of bills, 1914-1916; and bills and receipts, 1917-1925.
