Box II contains papers of the Perry family. Included are letters and bills mostly to Gurdon Perry and his wife as well as Gurdon Perry's military papers. Box III contains account books of Gurdon Perry and Fanny B. Bulkley's cookbook. Box IV contains unidentified photo albums.
